even date with these presents, *James Bunker* well and truly indebted to
The South Carolina Savings Bank, Fountain, S.C.
in the full and just sum of *Fifteen thousand (15,000.00)*
Dollars, to be paid *1,000.00 March 18th 1930; 1,000.00 June 18th 1930;*
1,000.00 May 18th 1930; 1,000.00 August 18th 1930; 1,000.00 July 18th 1930;
1,000.00 September 18th 1930; 1,000.00 October 18th 1930 and 700.00 November 18th 1930.
with interest thereon, from *Maturity* at the rate of *8* per cent. per annum to be
computed and paid *annually*

at and before the signing of these Presents the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bar-
gain, sell and release unto the said *The South Carolina Savings Bank*:
