in the State aforesaid, SENDS GREETING.

WHEREAS, we the said Jane McElrath and Sallie C. Paris

hereinafter called mortgagors, in and by us herewith stand firmly held and bound unto THE CITIZENS BUILDING AND LOAN ASSOCIATION, a corporation hereinafter called the mortgagee, in the full sum of Two Thousand Fifty Dollars, conditioned for the payment of the monthly sum of Ten dollars 68¢ on the FIFTH day of each and every month succeeding the date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS and also for ten per centum attorney fees in case of suit or collection by or through an attorney, which in addition to said debt is hereby secured and made a lien on the premises, as in and by the said note or obligation and condition thereof, reference being thereto had, will more fully appear.

NOW, KNOW ALL MEN, That we the said mortgagors, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the condition of said note or obligation, and, also, in consideration of the further sum of THREE DOLLARS, to us the said mortgagors, in hand, well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, we the said mortgagors, Have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said mortgagee;

our one fourth (1/4) undivided interest in all that lot of land situate in the County and State aforesaid O'Neal Township, having the following metes and bounds: Beginning at a stone, S. S. Lynn and H. A. Forrester corner, and running thence S. 46-45 W. 20.00 chs to an iron pin on H. A. Forrester line, thence N. 33-30 W. 17.50 chs to an iron pin, by Poplar tree on branch, thence by the meanderings of this branch approximately 17.48 chs to an iron pin, S. S. Lynn corner on East bank of branch, thence S. 50-30 E. 9.75 chs to the beginning corner, being designated as Lot #2 on a plat made by W. A. Christopher, Surveyor, October 9, 1924, and containing 25.35 acres, more or less, and is the same tract of land conveyed to J. J. Paris by G. W. Few by Deed recorded in R. M. C. Office for Greenville County in Vol 126, page 485.

Also, our undivided one fourth interest in all that tract of land in the County and State aforesaid, O'Neal Township, having the following metes and bounds: Beginning at an iron pin on the edge of a branch and runs thence N. 23-10 W. 9.25 chs to a stone, thence N. 46-45 E. 18.76 chs to an iron pin, thence N. 1-25 E. 6.00 chs to a stone; thence N. 37-30 W. 12.00 chs to a stake on the branch; thence N. 73-20 E. 15.50 chs along the meanderings of the branch to a stake by a poplar 3m; thence S. 33-30 E. 18.00 chs to an iron pin on the line of H. A. Forrester, thence S. 75-15 W. 9.90 chs to an iron pin on the branch; thence along the meanderings of the branch 26.41 to the beginning corner, containing 39.75 acres, more or less, and being designated as tract no 1 on a plat of the Annie B. Roe place.

Also, our undivided one-fourth interest in that other tract of land situate in the County and State aforesaid, having the following metes and bounds: Beginning on a stone 8m near the Jenkins Spring and runs thence N. 23-10 W. 3.83 chs to a stake in a branch; thence N. 72-30 E. 1.90 chs to a stake; thence N. 55-30 E. 1.97 chs to a stake; thence N. 31 E. 2.76 chs to a stake; thence N. 57-40 E. 1.72 chs to a stake; thence S. 50-15 E. 2.38 chs to a stake; thence S. 43-20 W. 9.50 chs to the beginning corner, containing 2.50 acres more or less. The last two described tracts are the same that were conveyed to J. J. Paris by Ora Turner by Deed recorded in R. M. C. Office for Greenville County in Vol 107 page 135.
