NOW KNOW ALL MEN, That I, the said Lucy L. Hindman

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

all that tract or lot of land in \_\_\_\_\_ Township, Greenville County, State of South Carolina.

Just outside the corporate limits of the City of Greenville and being known and designated as Lots No. 1, 2, and 3 of Block "N" on a plat of property known as "Highland Terrace" made by R. E. Dalton, Engineer, in August 1917, recorded in Plat Book "E" at Page 100; also lots nos. 19, 20, 21 and 22 of Block "A", as shown on said plat; also Lot No. 4 of Block "E" on plat made by Dalton & Neves, Engineers, recorded August 13, 1928 in Plat Book "H" at Page 208; also Lots nos. 1, 2 and 3 of Block "J" of said plat recorded in Plat Book "H" on page 208.

It is understood and agreed that the mortgage herein will release from said mortgage any one or more of the aforesaid lots upon payment to her of the sum of One Thousand (\$1,000.00) Dollars for the release of lot no. 4, Block "E", and upon payment to her of the sum of Six Hundred (\$600.00) for each particular lot set out and described as being in any block or section thereof, and upon any payment as aforesaid the same shall be applied upon the mortgage debt and interest upon that said amount shall cease at its payment.

This mortgage is given as additional security to a note given by Lucy L. Hindman to Sue J. Cleveland dated September 5, 1928 due September 5, 1931 and is given in consideration of the extension by the noteholder of the time of payment of same to November 5, 1935.
