SEND GREETING:

WHEREAS, I, *D. W. Payne*, the said *D. W. Payne*, in and by my certain even date with these presents, am in the full and just sum of Eight Thousand (\$8,000.00) Dollars, to be paid as follows: One Thousand (\$1,000.00) Dollars per month, beginning April 27, 1937 and one Thousand (\$1,000.00) Dollars on the 27th day of each month thereafter until paid in full, with interest thereon, from date *May 1938.* at the rate of 6% per cent. per annum to be computed and paid annually, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *One percent.* *Paid in full* besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me *SATISFIED AND CANCELLED AT* *May 18,* in hand well and truly paid by the said *People's National Bank, Greenville, S.C.* at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said *People's National Bank, Greenville, S.C.* the following described property, to-wit: *# 6146*

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina known as lot #7 of Monaghan Annex as shown on plat recorded in R. M. C. Office for Greenville County in Plat Book 8 at page 63 and more particularly described as follows:

Beginning at a stake on southwest corner of Smythe St. and Parker Road and running thence with west side of Smythe St. S. 6 1/4 W. 27 1/2 feet to a stake in line of lot #8; thence with line of lot #8 in a westerly direction 100 1/2 feet to a stake in line of lot #13; thence with line of lot #13 in a northerly direction 27 1/2 feet to a stake on south side of Parker Road; thence with said road S. 83 1/4 E. 100 feet to the beginning corner.

Also: all that other lot of land in Greenville Township, County and State aforesaid, on plat above referred to and known as lot #8 on said plat having a frontage of 27.5 feet on Smythe St. and running back by parallel lines 101 feet more or less, to line of lot #13.

Also: That other lot of land in Greenville Township, County and State aforesaid, known as lot #9 on plat above referred to and having the following lines and bounds, to-wit:

Beginning at a stake on the west side of Smythe St., 55 feet south of intersection of Smythe St. and Parker Road and running thence with Smythe Street S. 6 1/4 W. 27.2 feet to corner of lot #10; thence with line of lot #10 N. 83 1/4 W. 101.5 feet to a stake on line of lot #13; thence with line of lot #13, in a northerly direction 27.2 feet to a stake corner of lot #8; thence with line of lot #8 S. 1/83 1/4 E. 101 feet to beginning corner.
