Release

For value received, the Board of Church Extension of the Methodist Episcopal Church, South, Incorporated, does hereby release unto the Trustees of the Trinity Church, (Methodist, South) of Fountain Inn, South Carolina, their successors and assigns, the within described property from that certain lien of a mortgage recorded in Mortgage Book 205 at page 435, R. M. B. Office of Greenville County, South Carolina, said mortgage having been executed on June 5, 1929 by J. P. Kellett, R. A. Jones and A. D. Cannon, Trustees of the Fountain Inn Methodist Church, as a mortgage and refunding bond in the amount Seven Hundred Fifty (\$750.00) Dollars. The said property being released from the aforesaid mortgage is described as follows, to-wit:

"All that piece, parcel and lot of land lying and being situate in the Town of Fountain Inn, State and County aforesaid in Fairview Township,

Beginning at a point on the south side of Cemetery Street approximately 202 feet in an Easterly direction from a point on Weston Street; running thence South 35° 28' East 214.7 feet to a point in an unnamed street; running thence along said unnamed street North 53° 30' East approximately 29.4 to a point on unnamed street; thence North 53° 30' East 21.9 feet to the joint corner of lots of the aforesaid church property and the Fountain Inn public school property; thence along the line of the Fountain Inn public school property North 26° 30' West 206.7 feet to a point on Cemetery Street; thence South 62° 30' West 45.7 feet to a point on said Cemetery Street; thence continuing along Cemetery Street South 62° 30' West 33.2 feet to a point on Cemetery Street which is the beginning point.

This being the rear portion of the aforesaid church's lot, according to survey of H. J. Riddle, Surveyor, made August 1, 1940, see R. M. B. records for Greenville County in Plat Book, Book 2, page 129, Plat to be recorded.

It is in no wise the intention of the aforesaid Board to release any portion of that lot upon which the church is situated and the lien of its mortgage is retained on a lot approximately measuring 202⁰ on Cemetery Street; 230.9 feet on Weston Street; 189.9 feet on an unnamed street and 214.7 feet as a rear line.
