SEND GREETINGS:

WHEREAS I the said J. B. Hall

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of FIFTEEN HUNDRED & NO 100/100

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of FIFTEEN & NO 100/100

(\$ 15.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage, said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

C., the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, about 2 1/2 miles from the Greenville County Courthouse, on the north side of Sycamore Drive, being shown as Lot No. 135 on Plat of East Lynne Addition made by Dalton & Neves, Engineers, in May, 1933, recorded in the R. M. C. Office for Greenville County in Plat Book "H" at Page 220, and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the north side of Sycamore Drive, 100 feet East from Johnson Street, corner of Lot No. 134, and running thence with the line of said lot, N. 28-50 E. 150 feet to a stake in line of Lot No. 132; thence with the line of said lot, S. 61-10 E. 50 feet to an iron pin, corner of Lot No. 137; thence with the line of said lot, S. 28-50 W. 150 feet to a stake on Sycamore Drive; thence with the northern side of Sycamore Drive, N. 61-10 W. 50 feet to the beginning corner; being the same property conveyed to J.
