WHEREAS I the said J. M. Pollard

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of

TWENTY-EIGHT HUNDRED & NO/100 (\$ 2800.00 ) Dollars,

Beginning at a stake on the South side of Arthur Avenue, at corner of Lot No. 24, and running thence with the line of said lot, S. 44-46 E. 116 feet to an iron pin, corner of Lot No. 3; thence with the line of Lot No. 2, N. 32-42 E. 71 feet to an iron pin; thence in a Westerly direction 101.8 feet, more or less, to an iron pin on Arthur Avenue; thence with the Southern side of Arthur Avenue, S. 45-27 W. 60 feet to the beginning corner; being the same property conveyed to J. M. Pollard by Daisy I. Pollard, by deed dated February 22, 1940, and recorded herewith.
