TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Addie Tucker Watson, of Greenville, S. C., SEND GREETINGS:

WHEREAS I the said Addie Tucker Watson

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

TWO THOUSAND, THREE HUNDRED & NO/100

(\$2,300.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

TWENTY-ONE AND NO/100 (\$ 21.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I Addie Tucker Watson, the said

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in the City of Greenville, on the west side of Townes Street, and having the following metes and bounds, to-wit:

"BEGINNING at a point on the west side of said Townes Street, 150 feet south of the southwest corner on Croft and Townes Streets, and running thence N. 83-13 W. 131 feet to a stake on the west line of Lot No. 45; thence with the west line of Lot No. 45, S. 1-41 W. 50 feet to a stake; thence with the southern line of Lot No. 45, S. 83-13 E. 131 feet to Townes street; thence with Townes street, N. 1-41 E. 50 feet to the beginning corner, being the southern portion of Lot No. 45, of Section A, of the Stone Land Company, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "A", pages 337-345, Being the same lot conveyed to me by E. E. Stone, by deed dated July 2, 1919, and recorded in the R. M. C. office for Greenville County in Vol. 45, page 538."
