unto the Mortgagee, its successors and assigns, the following described real estate situated in the county of Greenville State of South Carolina:

known and designated as Lot No. 38 of Lanneau Drive Highlands according to plat made by Dalton & Neves, Engineers, August 1937, and recorded in the R. M. C. Office for Greenville County in Flat Book D, Pages 288-289, and having the following metes and bounds, to-wit:
