I, Lee P. Ramsey, of Greenville

SEND GREETINGS:

WHEREAS I, the said Lee P. Ramsey

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of

TWO THOUSAND AND NO/100

(\$2,000.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

TWENTY AND NO/100

(\$20.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which are secured under this mortgage); as in, and to the full and true reference being thereunto had, will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND

LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Paris Mountain Township, about 4 miles west of the City of Greenville, containing 29.42 acres, more or less, and having the following metes and bounds, according to a survey made by C. M. Furman, Engr., Sept. 4, 1934, to-wit:

BEGINNING at a point in the center of a road, leading to Greenville, at corner of W. T. Bridges and W. T. Weaver, and running thence S. 49-15 E. 140 feet; thence S. 44 E. 109 feet; thence S. 19-20 E. 118 feet; thence S. 50-35 E. 134 feet; thence N. 39 E. 926 feet to a pine stump; thence N. 20-40 W. 216 feet; thence N. 8-10 E. 128 1/2 feet; thence N. 82-25 E. 628 feet; thence N. 20-30 W. 26 feet to rock; thence N. 81-35 W. 1006 feet to black gum; thence S. 8-10 W. 1195 feet to rock; thence S. 50-30 W. 706 feet; thence S. 54-40 E. 444 feet to center of public road; thence with said road S. 48-15 W. 335 feet to the beginning corner, and being the same property conveyed to me by James D. Thompson, by deed dated July 6, 1938, and recorded in the R. M. C. Office for Greenville County in Vol. 205, page 4.
