C.**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Twenty and 66/100** Dollars (\$ **20.66**), commencing on the first day of **August**, 19 **42**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **July**, 19 **57**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Southwest side of Orlando Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 76 on plat of Paris-Piney Park, recorded in the R. M. C. Office for Greenville County in Plat Book H, at pages 19 and 20, and also being shown as Lot No. 76 on plat of Leawood Extension, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book M, at page 35, and having, according to a recent survey made by R. E. Dalton, July 8, 1942, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Southwest side of Orlando Avenue, at joint front corner of Lots No. 75 and 76, said pin also being 551 feet in a Southeasterly direction from the point where the Southwest side of Orlando Avenue intersects with the Southeast side of Paris Mountain Road and running thence with the line of Lot No. 75, S. 33-54 W. 150 feet to an iron pin; thence S. 56-06 E. 50 feet to an iron pin; thence with the line of Lot No. 77, N. 33-54 E. 150 feet to a stake on the Southwest side of Orlando Avenue; thence with the Southwest side of Orlando Avenue, N. 56-06 W. 50 feet to the beginning corner.
