WHEREAS, the Mortgagor is well and truly indebted unto Liberty Life Insurance Company

, a corporation

organized and existing under the laws of State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of two thousand six hundred fifty Dollars (\$ 2,650.00), with interest from date at the rate of four and one-half per centum ($4\frac{1}{2}$ %) per annum until paid, said principal and interest being payable at the office of Liberty Life Insurance Company in Greenville, S. C. or at such other place as the holder of the note may designate in writing, in monthly installments of Fourteen & $\frac{73}{100}$ Dollars (\$ 14.73), commencing on the first day of September, 1942, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 1967.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

Known and designated as Lot No. 79 of Anderson Street Highlands as shown on plat made by Dalton & Neves in 1939, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book J, Page 157, and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the Southeastern side of East King Street, joint corner of Lots Nos. 78 and 79, and running thence with East King Street S. 47-20 E. 50 feet to an iron pin, joint corner of Lots Nos. 79 and 80; thence with the dividing line of said lots S. 42-40 W. 150 feet to an iron pin, joint rear corner of Lots Nos. 79, 80, 47 and 48; thence with the rearline of Lot No. 79 N. 47-20 W. 50 feet to an iron pin, joint rear corner of Lots Nos. 78, 79, 48 and 49; thence with the dividing line of Lots Nos. 78 and 79 N. 42-40 E. 150 feet to the point of beginning.

The Mortgagor further agrees that should this mortgage and the note secured hereby not be eligible for insurance under the National Housing Act within eight months from the date hereof (Written statement of any officer or employee of the Federal Housing Administration dated subsequent to the eight months' time from the date of this mortgage, declining to insure said note and this mortgage, being deemed conclusive proof of such ineligibility) the Mortgagee or the holder of the note may, at its option, declare all sums secured hereby immediately due and payable.
