M. C. office for Greenville County in Mortgage Book 247, page 156, does hereby release and forever discharge from the lien of said mortgage the following described tract of land:

A tract or parcel of land lying and being in Gantt Township, Greenville County, S. C. containing 0.93 acre, more or less, being a 70 foot strip of land extended 35 feet on each side of and parallel to the center line described as follows: Beginning at a point on the west property line of Mary B. McWhite south 4 degrees 30 minutes west 725 feet from the northwest corner of said tract; thence south 77 degrees 10 minutes east 581.57 feet to a point in the east property line of the aforementioned tract south 4 degrees 30 minutes west 728.15 feet from the northeast corner of said tract on Whitehorse Road. Being a part of the same land conveyed to Mary B. McWhite by Florence T. Batson Admx., as recorded in Deed Book 67, page 120, of the Public Records of Greenville County, S. C.

This is the same tract of land involved in condemnation proceeding entitled United States of America, petitioner, versus J. H. Earle, et al, defendants, the same being designated in said proceeding as tract No. 34.

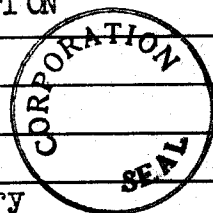
