TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Charles E. Green and Dorothy R. Green SEND GREETINGS:

WHEREAS we the said Charles E. Green and Dorothy R. Green

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of FOUR THOUSAND, SEVEN HUNDRED & NO/100

(\$4,700.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of THIRTY-SIX AND NO/100 (\$36.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That we the said Charles E. Green and Dorothy R. Green

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to us

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, on the north side of Carroll street and being known and designated as Lot No. 4, of the property of S. L. Styles, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book L, at page 151, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Carroll street at the joint corner of Lots Nos. 3 and 4, which point is 144.7 feet west from the northwest corner of the intersection of Carroll street and McPherson Lane, and running thence along the north side of Carroll street, N. 73-22 W. 72 feet to an iron pin; thence N. 18-19 E. 159.2 feet to an iron pin on the south side of a branch; thence along the branch as the line in a northeasterly direction to an iron pin, joint rear corner of Lots Nos. 1 and 4; thence along the line of Lot No. 1, S 15-34 E. 29 feet to an iron pin in line of Lot No. 1, joint rear corner of Lots Nos. 3 and 4; thence along the joint line of said Lots 3 and 4, S. 15-58 W. 182 feet to the beginning corner on Carroll street. Being the same lot conveyed to me by J. W. Norwood, Jr., by deed of even date herewith, not yet recorded, this mortgage being given to secure the unpaid portion of the purchase price thereof."
