MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Frank B. Johnson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-seven Hundred Fifty and No/100

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, on the Western side of Alice Street, near the City of Greenville, being shown as Lots Nos. 19 and 20 of Block G on Plat of Woodville Heights, made by W. J. Riddle in December, 1940, recorded in Plat Book L at Pages 14 and 15, and described as follows:

BEGINNING at a stake on the Western side of Alice Street at the corner of Lot No. 18, and running thence with Lot No. 18, N. 55-10 W. 293.3 feet to a stake on Pine Street; thence with the Eastern side of Pine Street, N. 36-20 E. 120 feet to stake, corner of Lot No. 21; thence with the line of said Lot, S. 60-40 E. 206.8 feet to a point on Alice Street; thence with the Western side of Alice Street, S. 3-00 W. 160 feet to the beginning corner."
