MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, M.K. Thomas

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Hundred & No/100 - - - - -

DOLLARS (\$500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being known and designated as Lot No. 5 on plat of said property, recorded in Plat Book G at Page 138 and being more particularly described according to said plat, as follows:

"BEGINNING at a point on Hilltop Avenue, 267 feet East of Franklin Road at the joint front corner of Lots Nos. 4 and 5, and running thence with the joint line of said lots, S. 46-35 W. 149.1 feet to iron pin; thence S. 46-55 E. 50 feet to iron pin, joint rear corner of Lots Nos. 5 and 6 and running thence with joint line of said lots, N. 46-15 E. 145.6 feet to iron pin on Hilltop Avenue; thence along said Hilltop Avenue, N. 43-00 W. 50 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor herein by R. J. Thomas by deed October 8, 1945, recorded in Volume 281 at Page 244, and being the same premises conveyed to R. J. Thomas and M. K. Thomas by Emmie R. Thackston, Administrator and Trustee of the Will of Annie T. Goodlett, by deed dated May 30, 1932, recorded in Volume 161 at Page 471.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
