WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Four Hundred & No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being known and designated as Lot No. 10 of Block D as shown on plat of Melville Land Company, Subdivision No. 2, recorded in Plat Book A at Page 97, and being more particularly described, according to said plat, as follows:

" BEGINNING at an iron pin on Burdett Street, joint front corner of Lots Nos. 9 and 10, and running thence with the line of said lots, N. 43-45 E. 147.1 feet to an iron pin in line of Lot No. 2; thence with the line of Lot No. 2 in a Southeasterly direction 50.9 feet to an iron pin, joint rear corner of Lots Nos. 10 and 11; thence with the line of said lots, S. 43-45 W. 156.75 feet to an iron pin on Burdett Steeet; thence with said Street, N. 46-15 W. 50 feet to the beginning corner."
