TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Roy F. Vaughan and Marie S. Vaughan
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Nine Hundred & No/100 DOLLARS (\$2,900.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the North side of Sidney Street, known as Lots Nos. 11 and 12 on Plat of property of J. M. Perry, recorded in Plat Book H at Page 184 in the R.M.C. Office for Greenville County, and more particularly described according to said Plat as follows

"BEGINNING at an iron pin on the North side of Sidney Street, joint corners of Lots Nos. 10 and 11, and running thence N. 31-30 W. 150 feet to an iron pin, rear corner of Lots Nos. 10 and 11; thence S. 58-30 W. 100 feet to an iron pin, rear corner of Lots Nos. 12 and 13; thence S. 31-30 E. 150 feet to an iron pin on Sidney Street; joint corner of Lots Nos. 12 and 13; thence along Sidney Street, N. 58-30 E. 100 feet to the beginning corner."

Said premises being the same conveyed to the mortgagors by J. M. Perry by deed dated September 4, 1945, recorded in Book of Deeds 279 at Page 435.
