TO ALL WHOM THESE PRESENTS MAY CONCERN: I, J. P. Bowden

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Five Hundred and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Laurens Road in the City of Greenville, being shown as Lot No. 71 of Block F on plat of East Park, recorded in Plat Book 383, and described as follows:

"BEGINNING at a stake on the Southern side of Laurens Road, 200 feet West from Washington Road at corner of Lot No. 70, and running thence with the line of said lot in a Southerly direction, 196-feet to a stake in line of Lot No. 83; thence with the line of said lot, N. 40-30 W. 53 feet to a stake at corner of Lot No. 72; thence with the line of said lot in a Northerly direction 178 feet to a stake on Laurens Road; thence with the Southern side of Laurens Road, S. 68-30 E. 50 feet to the beginning corner."
