MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Thomas F. Bradford,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-five Hundred and No/100 DOLLARS (\$6,500.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Southeast side of Grace Street, near the City of Greenville, being shown as Lot No. 34 on Plat of property of E. G. Glenn, made by C. M. Furman, Eng., March 28, 1923, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book F at Page 148, and having, according to said Plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Southeast side of Grace Street at join front corner of Lots Nos. 33 and 34, and running thence with the line of Lot No. 33, S. 28-22 E. 150 feet to an iron pin; thence with the rear line of Lot No. 9, S. 61-38 W. 55 feet to an iron pin; thence with the line of Lot No. 35, N. 28-22 W. 150 feet to an iron pin on the Southeast side of Grace Street; thence with the Southeast side of Grace Street, N. 61-38 E. 55 feet to the beginning corner."
