MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Wiley R. Clark and Margaret S. Clark

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Five Hundred Fifty and No/100 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of East King Street, being known and designated as Lots Nos. 69, 70 and 71 on plat of Anderson Street Highlands, made by Dalton and Neves, in 1939, and recorded in Plat Book J at Page 157, and having, according to said plat, the following metes and bounds, when described together:

"BEGINNING at an iron pin on the Southern side of East King Street at the joint front corner of Lots Nos. 68 and 69, and running thence along the Southern side of East King Street, S. 47-20 E. 150 feet to an iron pin, corner of Lot No. 72; thence with the line of Lot No. 72, S. 42-40 W. 150 feet to an iron pin; thence with the rear lines of Lots Nos. 56, 57 and 58, N. 47-20 W. 150 feet to an iron pin, corner of Lot No. 68; thence with the line of Lot No. 68, N. 42-40 E. 150 feet to an iron pin, the point of beginning."
