MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Fordie A. Edwards

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, near the Town of Greer, S. C., and being known and designated as Lots Nos. 13 and 14 on plat of property of N. M. Cannon as shown on plat recorded in Plat Book F at Page 199, and being more particularly described, according to said plat, as follows:

"BEGINNING at an iron pin on the Northern side of Buncombe Street, joint front corner of Lots Nos. 12 and 13, and running thence with the joint lines of said lots N. 13 W. 204.5 feet to an iron pin; thence with the line of land now or formerly owned by A. R. Woods; thence with said line, S. 77 W. 100 feet to an iron pin, joint rear corner of Lots Nos. 14 and 15; thence with the joint lines of said lots S. 13 E. 204.5 feet to an iron pin on the Northern side of Buncombe Street; thence with said Street, N. 77 E. 100 feet to the beginning corner."
