MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Marion L. Huffling
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Two Hundred and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the northern side of Heyward Street (formerly Verner Springs Road), as shown on plat of property of J. C. Southerlin and L. B. Huffling, dated November 11, 1946, by Dalton and Neves, Engineers, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin on the northern side of Heyward Street, 86.9 feet west of the intersection of Heyward Street and Old Buncombe Road, and running thence with Heyward Street, N. 74-31 W. 57.2 ft. to iron pin; thence N. 13-55 E. 66 ft. to iron pin; thence S. 74-30 E. 58.2 ft. to iron pin; thence S. 14-49 W. 66 ft. to iron pin, the beginning corner, being the same premises conveyed to the mortgagor herein by G.
