NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **being known and designated as the rear portions of lots 36 and 37 as shown by the plat of property of Stone Land Company dated June 4, 1909, having the following metes and bounds, to-wit:-**

BEGINNING at a point of a 60 foot street joint corner of lots 31 and 37, and running thence with said street, S. 71-20 E. 56 1/2 feet to an iron pin on said street; thence S. 18-30 W. 133.6 feet to an iron pin on the joint line of lots 35 and 36; thence N. 71-20 W. along the joint line of lots 36 and 35, 56 1/2 feet to an iron stake, joint corner of lots 31, 35 and 36; thence N. 18-30 E. 133.6 feet along the back line of lots 36 and 37 and the side line of lot 31 to the beginning corner.
