AGREEMENT FOR EXTENSION OF LOAN

WHEREAS, there remains unpaid on a certain note and mortgage given by Annie Beale Jones and Juliet Jones to Liberty Life Insurance Company dated September 30, 1946 covering property in Greenville County, South Carolina, said mortgage being of record in the R.M.C. Office for Greenville County in Mortgage Book 352, page 143, the sum of Ninety-eight Hundred (\$9,800.00) Dollars with interest thereon from December 15, 1946, and

WHEREAS, Ruth D. Herr is now the owner of the premises covered by the above mentioned / mortgage, and WHEREAS, the said Ruth D. Herr has requested that Liberty Life Insurance Company extend the time of payment of said note as hereinafter provided, which said Liberty Life Insurance Company has consented and agreed to do.

NOW THEREFORE, in consideration of the premises, I, Ruth D. Herr, do hereby agree to pay to Liberty Life Insurance Company the sum of Ninety-eight Hundred (\$9,800.00) Dollars, that being the balance due on the note above mentioned with interest thereon from December 15, 1946 until the maturity of said note at the rate of four and one-half (4½) per cent per annum, said principal and interest to be paid in monthly installments, as follows:

BEGINNING on the 15th day of January, 1947, and on the 15th day of each month of each year thereafter the sum of \$101.63 to be applied on the interest and principal of this note, said payments to continue up to and including the 15th day of November, 1956, and the balance of said principal and interest to be due and payable on the 15th day of December, 1956; the aforesaid monthly payments of \$101.63 each are to be applied first to interest at the rate of four and one-half (4½) per centum per annum on the principal sum of \$9,800.00 or so much thereof as shall, from time to time, remain unpaid, and the balance of each monthly payment shall be applied on account of principal.

IT IS FURTHER UNDERSTOOD that all other terms and conditions and conditions contained in the said note and mortgage shall remain as written except as herein modified.
