MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, W. B. Greyard
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Hundred and No/100 DOLLARS (\$ 1500.00), with interest thereon from date at the rate of four and one-half per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of the Augusta Road, and being more particularly described as follows:

"BEGINNING at a stake on the Eastern side of the Augusta Road at the Southern corner of Lot No. 1, as shown on plat recorded in Plat Book "F" at Pages 261 and 262, and running thence along the Augusta Road, N. 46-55, W. 81.4 feet to a stake; thence in a Northeasterly direction, approximately 200 feet to a stake at joint rear corner of Lots Nos. 2 and 4; thence N. 59-20 E. 60 feet to a stake; thence S. 31-30 E. 81.4 feet to a stake; thence S. 58-45 W. 237 feet to a stake on the Augusta Road; the point of beginning; being the major portion of Lot No. 1 as shown on plat above mentioned."

Said premises being the same conveyed to the mortgagor deed dated December 12, 1946, recorded in Volume 303 at Page 440.
