MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Hattie B. Harmon

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Nine Hundred and No/100 - - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Mountain View Avenue being known and designated as Lot #24 on plat of North Park recorded in Plat Book K, at pages 48 and 49, and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the South side of Mountain View Avenue at the joint front corner of lots 23 and 24 and running thence with line of lot 23 S. 19 W. 175.8 feet to an iron pin, rear corner of lot 21; thence with the rear line of lot 21 in a Westerly direction 55 feet to an iron pin, corner of lot 25; thence with line of lot 25, N. 10 E. 180.1 feet to an iron pin on Mountain View Avenue; thence with South side of Mountain View Avenue, S. 68-20 feet to the point of beginning.
