I, Kathleen Garrett, of Greenville County

SEND GREETINGS:

WHEREAS I, the said Kathleen Garrett

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of THREE THOUSAND, FIVE HUNDRED AND NO/100

(\$ 3,500.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of THIRTY-FIVE AND NO/100

(\$ 35.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Kathleen Garrett

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

"BEGINNING at an iron pin on the northeast side of North Franklin Road at the corner of Lot No. 303, and running thence along the line of that lot, N. 25-34 E. 185 feet to an iron pin; thence S. 81-06 E. 104 feet, more or less, to an iron pin in the line of Lot No. 305; thence along the line of that lot, S. 25-34 W. 215 feet to an iron pin at the corner of said lot on North Franklin Road; thence along the line of said North Franklin Road, N. 64-26 W. 100 feet to the beginning corner. Being the same lot conveyed to me by L. T. Chapman by deed dated February 28, 1946 and recorded in the R.M.C. Office for Greenville County, in Vol. 288, at page 39.
