Riddle, Surveyor, August 1945, and having according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Eastern side of Dunham Bridge Road, corner of property now owned by J. M. Trammell and running thence along the line of said Trammell property S. 55-55 E. 546 feet to an iron pin corner of property of T. C. Collins; thence N. 15-56 E. 115.35 feet to a point in the center of Lot No. 11, corner of property of Johnny T.
