I, Mrs. Lula Bradley - - - - - SEND GREETINGS:

Whereas, I the said Mrs. Lula Bradley - - - - -
in and by my certain promissory note in writing, of even date with these presents, I am
well and truly indebted to Bank of Piedmont

in the full and just sum of Five Hundred and No/100 - - - - -
---(\$-----) Dollars, to be paid Payable one year from date - - - - -

with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Bank of Piedmont, its successors and assigns:-

"All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, on waters of Grove Creek and Saluda River, having the following courses and distances, according to survey and plat made by C. H. Millard, Engr., February, 1925.

BEGINNING at a dogwood 3X and running thence S. 86-08 E. 563.6 feet to stake; thence N. 10-10 E. 852.7 feet to stone ; thence N. 9-45 E. 417.7 feet to iron pin; thence S. 64-49 E. 828.4 feet to iron pin on plantation road; thence with plantation road S. 25-30 W. 946.7 feet to the beginning, containing 16.9 acres, more or less.

It is further stated that a right-of-way was granted to John Henry Wilson on the West side of said property and being eight feet wide, but has not been recorded.

This is the same tract of land conveyed to Mrs. Lula Bradley by Y. G. Williams by deed dated Nov. 20, 1939 and recorded in office of R.M.C. for Greenville County in Vol. 216 page 85.
