The makers reserve the right to increase the monthly instalment payments to an amount not in excess of \$100.00 per month. Monthly instalments to be first applied to interest, balance to principal

from date at the rate of five (5) per centum per annum with interest until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to US in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

and in Ward One of the City of Greenville, on the East side of Wilton Street and being known and designated as the rear portion of Lot No. 5, of Map 2, of a subdivision of the property of Mountain City Land and Improvement Company, as recorded in the R. M. C. Office for Greenville County in Deed Book VV, at page 542, and being more particularly described as follows:

BEGINNING at a point on the East side of Wilton Street 150 feet south of the southeast corner of the intersection of Stone Avenue and Wilton Street, and running thence along the East side of Wilton Street, S. 5 1/2 W. 59 feet, more or less, to an iron pin at the corner of property formerly belonging to W. C. Cleveland; thence along the line of the Cleveland property, S. 87 E. 96 feet to an iron pin at the rear corner of Lot No. 4; thence along the line of Lot No. 4, N. 5 1/2 E. 55 feet, more or less, to an iron pin at the rear corner of the lot now or formerly belonging to Annie H. Smith; thence on a line approximately parallel with Stone Avenue, N. 84 1/2 W. 96 feet to the beginning corner. Subject, however, to the terms of and together with all interests in the right-of-way or easement which goes with said lot, as stipulated in a certain deed from T. E. Gibson to Annie H.
