at the rate of six per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in the City of Greenville (formerly School District 8-GD), and being known and designated as Lot No. 54 of the property of Ables & Rasor as shown on plat thereof made by Fitzpatrick-Terry Company, Engrs., in September, 1919 and recorded in the R. M. C. office for Greenville County in Plat Book E, at page 153, and being more particularly described as follows, to-wit:

"BEGINNING at an iron pin on the South side of Club Drive at the corner of Lot No. 53, which point is 232 feet west of the intersection of Ridge Drive, and running thence along the line of Lot No. 53, in a southeasterly direction, 181.3 feet to an iron pin; thence in a southwesterly direction 82 feet to an iron pin at the rear corner of Lot No. 55; thence along the line of Lot No. 55, in a northwesterly direction, 180.1 feet to an iron pin on the south side of Club Drive; thence along the south side of said Club Drive, in a northeasterly direction, 80 feet to the beginning corner.
