Whereas, I, the said Odell Williams

, with interest thereon from date

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, lying and situated near Flemings Grocery Store on the West side of Highway # 29, between Piedmont and Plezer and having the following courses and distances to wit:

Beginning at corner of lot # 2 thence S-60-W 3.57 to stake, thence S-25 E 94 links or 62 feet to iron pin, thence N-87-E 3.86 chains to iron pin North side of road, thence along said dirt road 2.98 chains to the beginning corner, being known as lot # 3 of the survey of J.A. Pickens, April, 7th, 1945.
