WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as the Northeastern portion of Tract No. 22 as shown on a plat of the Estate of W. R. Jones prepared by Dalton and Neves, Engineers, in July, 1945, recorded in the Office of R. M. C. for Greenville County in Plat Book "B" at Page 45, and being more particularly described, according to said plat, as follows:

"REGINWING at an iron pin on the Southern side of Crest Ridge Street, which point is 75 feet East of the joint front corner of Tracts Nos. 21 and 22 in line of property conveyed to W. C. Stewart, Jr., and running thence S. 12-51 E. 200 feet to an iron pin, joint rear corner of lot conveyed to W. C. Stewart, Jr.; thence N. 76-29 E. 80 feet to an iron pin in line of Tract No. 23; thence W. 12-51 W. 200 feet to an iron pin on the Southern side of Crest Ridge Street; thence along said Street, S. 77-05 W. 80 feet to the beginning corner."

Said premises being a portion of the property conveyed to the mortgagors by Ruth J. Freeland by deed dated March 11, 1948, recorded in Volume 340 at Page 43.
