All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, on the White Horse Road about four miles from Greenville County Court House, being a portion of Lot No. 5, as shown on Plat of property of Julia D. Charles by W. J. Riddle, Surveyor, dated April 30, 1936, and being more particularly described as follows:

BEGINNING at an iron pin, corner of Lot No. 6 (land of R. M. Kennedy) thence with line of said Lot, S. 31-20 W. 325 feet to an iron pin; thence in a Southeasterly direction 100 feet to iron pin in line of the property of the grantor; thence N. 31-20 E. 325 feet to iron pin on the South side of the White Horse Road; thence with the South side of said Road, N. 41-36 W. 100 feet to the beginning corner.
