MORTGAGE OF

To All Whom These Presents May Concern:

I, James Bayliss Keeler, of Greenville County, SIGNED GUARANTEE:

WHEREAS, I the said James Bayliss Keeler

in and by my certain promissory note, in writing, of even date with these presents, do well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of SEVEN THOUSAND AND NO/100 - - - - - (\$ 7,000.00 )

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of FIFTY AND NO/100 - - - - - (\$ 50.00 ) Dollars on the first

day of each and every calendar month hereafter in advance, until the full principal and interest has been paid, said monthly payments shall be applied first to the payment of interest, and then to the payment of principal; said note further providing that if any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the regulations of this mortgage, the whole amount due under said note, shall, at the option of the Association, become immediately due and payable, who may sue thereon and foreclose this mortgage, and further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I, the said James Bayliss Keeler

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

the said James Bayliss Keeler

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, in that section known as Sans Souci, about two miles North of the City of Greenville, on Blue Ridge Drive, between King Street and the Perry Road, said lot having the following lines, courses and distances, to-wit:

"BEGINNING at an iron pin on the Northern edge of a five foot sidewalk running along Blue Ridge Drive, said pin being the joint front corner of Lots Nos. 17 and 18, and running thence along the Northern edge of said sidewalk, S. 87-37 W. 60 feet to an iron pin, joint corner of Lots Nos. 16 and 17; thence along the eastern line of Lot No. 16, N. 2-25 W. 203 feet to an iron pin, joint rear corner of Lots Nos. 16 and 17; thence along the Southern line of Lot No. 29, N. 89-03 E. 60 feet to an iron pin, joint rear corner of Lots Nos. 17 and 18; thence along the Western line of Lot No. 18, S. 2-25 E. 202 feet to an iron pin, the beginning corner; said lot being known and designated as Lot No. 17 on plat of said property, recorded in the R. M. C. office for Greenville County, South Carolina, in Plat Book "K", at page 303, which plat is hereby referred to and made a part hereof." Being the same lot of land conveyed to me by William T.
