Highway No. 25) and between West Plaza and East Plaza, of Lewis Plaza, Inc., and having the following metes and bounds, courses and distances, according to survey and plat made by Dalton and Neves, Engineers, May, 1948, to-wit:

BEGINNING At an iron pin at the Northeast corner of the intersection of Augusta Road (U. S.
