The Mortgagor covenants that he is lawfully select of the premiers acremators described in fee simple absolute, that he has good right and lawful anthority to millions are mounted and that the premises are free and clear of all liens and accomprance makes the Martinger further covenants to warrant and forever defend all and singlets the measure and the same of any part thereof.

The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the indebtedness endeanded by the said note, at the times and in the manner therein provides.
- 2. That this mortgage shall secure the Mortgages for such further sums at met be advanted hereafter, at the option of the Mortgages, for the payment of taxes, insurance personness, such as sessments, repairs or other purposes pursuant to the covenants herein, and also any further loans, advances, readvances or credits that may be made hereafter to the Mortgages by the Mostgages; and that all sums so advanced shall bear interest at the same rate at the Mortgage debt and shall be payable on demand of the Mortgages, unless otherwise provided in writing.

- 8. That, at the option of the Mortgagee, this mortgage shall become due and payable forthwith if the Mortgagor shall convey away said mortgaged premises, or if the title shall become vested in any other person in any manner whatsoever other than by death of the Mortgagor.
- 9. It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue. If there is a default in any of the terms, conditions or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgagee, all sums then owing by the Mortgagor to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed.
