All that piece, parcel or lot of land in Cleveland Township, Green-ville County, State of South Carolina, known and designated as Lot No. 33 of Blythe Shoals lots, property of Mrs. Rena Rice Geer as shown on plat made by Dalton & Neves, in July 1939, revised March 1940, recorded in the R. M. C. Office for Greenville County in Plat Book "K", Page 38, and having according to said Plat the following metes and bounds,
