"All that certain piece, parcel or lot of land, with all improvements thereon, or impression constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as lot # 17 as shown on a plat of Augusta Acres, Property of Marsman, Inc., prepared by Dalton & Neves, Engineers, 1946, recorded in Plat Book "S" at Page AD, being more particularly described according to said plat as follows:
