To All Whom These Presents May Concern:

We, Harry F. Smith and Frances B. Smith xxxxxxxx SEND GREETING:

WHEREAS, we the said Harry F. Smith and Frances B. Smith in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Six Hundred xxxxxxxxxxxxxxxxxxxxxxxx (\$ 600.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Nine and 60/100 xxxxxxxxxxxxxxxxxxxxxxxx (\$ 8.60) dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said Harry F. Smith and Frances B. Smith, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the North side of Bearden Avenue in the Town of Greer, and known and designated as Lot #1 on plat of the property of B. T. Greene, prepared by H. S. Brockman, November 2, 1940, and having the following courses and distances, to wit:-

BEGINNING at the corner of Bearden Avenue and an 8 foot alley, and runs thence with said alley N 1-45 W 165 feet to iron pin; thence N 81-09 W 50 feet to iron pin, cornering on line of Lot #3; thence S 1-45 E 15 feet to iron pin, joint corner of Lots #3 and #2; thence same course 150 feet to joint corner of Lots #1 and #2 on the North side of Bearden Avenue; thence with said Avenue S 81-09 E 50 feet to the beginning corner. Being the same lot of land conveyed to us by W. C. Lindley by DEED recorded in R.M.C. Office for Greenville County in Vol 242, page 397.

Also, with the right and privilege of use of the said 8 foot alley to the East of the above described lot, as granted to us.
