That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the North side of Sunny Lane in Greve Township, being shown as Lot 17 on plat of property of R. E. Dalton made by Dalton & Neves, Engineers, November 1947, recorded in the R.M.C. Office for Greenville County in Plat Book S, page 15 and having according to said plat, the following metes and bounds, to wif:-

an iron pin on the North side of Sunny Lane, joint front corner of Lots 16 and 17, and running thence with the line of Lot 16 N 12-40 E 599 feet to iron pin in branch; thence down said branch as the line (the traverse line being N 88-07 W 228.3 feet) to a point in branch at rear corner of Lot 18; thence along the line of Lot 18 S 11-45 W 534 feet to iron pin on the North side of Sunny Lane; thence with the North side of Sunny Lane S 70-45 E 100 feet to iron pin; thence continuing with Sunny Lane along curved line ( the chord being S 72-05 E 117 feet) to the beginning corner.
