"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the East side of Piedmont Avenue, being shown and designated as Lot No. 16 on Plat of Edgemont, recorded in Plat Book D at Page 35, and having, according to said Plat, the following metes and bounds, te-wit:

"MEGINMING at an iron pin on the East side of Piedmont Avenue at the joint front corner of Lots Nos. 16 and 18, and running themee with the line of Lot No. 18, N. 80-30 E. 150 feet to an iron pin; thence N. 9-30 W. 60 feet to an iron pin, corner of Lot No. 14; themee with the line of Lot No. 14, S. 80-30 W. 150 feet to iron pin on Piedmont Avenue; thence with the Eastern side of Piedmont Avenue, S. 9-30 E. 60 feet to the point of beginning."

Said premises being the same conveyed to the mortgager by deed dated May 4, 1935, recorded in Book of Deeds 180 at Page 180.
