We, Colie L. Sullivan and Willie Pearl C. Sullivan, of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto LIBERTY LIFE INSURANCE COMPANY

All that piece, parcel or lot of land with the improvements thereon situated lying and being in Duncan Mills Village, Greenville County, South Carolina, and being more particularly described as Lot No. 60, Section 1, as shown on a plat entitled "Subdivision for Duncan Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., on June 7, 1948, revised June 28, 1948, and August 7, 1948, and recorded in the R. M. C. Office for Greenville County in Plat Book S, at pages 173-177, inclusive. According to said plat the within described lot is also known as No. 19 Taylor and fronts thereon 55 feet.
