I, JACK MORROW, of
Greer, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Greer

, a corporation
organized and existing under the laws of South Carolina , hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Eighteen Hundred - - - - -**
Dollars (\$ **1800.00**), with interest from date at the rate of **four and one-half** per centum
(**4½%**) per annum until paid, said principal and interest being payable at the office of
Bank of Greer in **Greer, S. C.** ,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Thirteen and 77/100 - - - - - Dollars (\$ **13.77**),
commencing on the first day of **August** , 19 **49** , and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of **July** , 19 **64** .

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville** ,
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,
lying and being in or near the City of Greer, Greenville County, South Carolina,
and being more particularly described as Lot No. 16, as shown on a plat en-
titled "A Subdivision for McCall Manufacturing Company, Greer, S. C.", made by
Pickell & Pickell, Engineers, Greenville, S. C., May, 1949, and recorded in the
R. M. C. Office for Greenville County in Plat Book S, at page 76. According to said
plat the within described lot is also known as No. 209 Franklin
Street (Avenue) and fronts thereon 79 feet.

This is the identical property this day conveyed to the Mortgagor by McCall
Manufacturing Company by its deed contemporaneously delivered and to be contempora-
neously recorded with this mortgage in the R. M. C. Office for Greenville County,
S. C.

This mortgage is given to secure a portion of the purchase price of the within
described property and includes jacket water heater and tank installed in said
premises.
