"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, about 5 miles East of the Greenville Courthouse and lying about one-half mile South of the Roper Mountain Baptist Church, and having, according to a survey prepared by G. A. Ellis, Surveyor, August 26, 1938, the following metes and bounds, to-wit:

*BEGINNIEG at a pin in the road at the corner of Roscoe Jones land, and running thence with the Jones line, S. 46-45 E. 909 feet to a pin at a branch on Roscoe Jones line; thence Northeasterly with the branch as a line, 665 feet to a pin near a gully in said branch (Watson land, formerly known as McSwain land); thence with the Mc-Swain or Watson land along the line of a discontinued road, N. 43-45 W. 915 feet to a pin in the first named road, and on the line of Haynsworth land; thence along said road, S. 42-30 W. 700 feet to the beginning corner, containing 14.8 acres, more or less; being the same premises conveyed to the mortgagor by E.
