

Beginning at a stake on the southern side of East McBee Avenue at corner of lot formerly owned by William Lebby, and running thence with the southern side of East McBee Avenue S. 53-10 W. 50 feet to stake; thence S. 14-49 E. 317.5 feet to stake on right-of-way of C. & W. C.
