C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about one-fourth mile southeast from the Town of Green, being known as Lot # 13 on a plat prepared for IV M. Wood Estate, by H. S. Brockman, Surveyor, of Green, said plat dated March 20, 1946; said property having the following courses and distances to wit:
