TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. H. STROUD

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand & no/100 - - - - - DOLLARS (\$ 6,000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, containing 20.60 acres, more or less, and having according to plat of property of Dock J. Hudson, recorded in Plat Book "O", page 153, R. M. C. Office for Greenville County, S. C., the following metes and bounds, to-wit:

BEGINNING at a point in the center of the Stenhouse Road, East of and just off of the New Augusta Road, and running thence with the center of said Stenhouse Road, S. 58-30 W. 60.9 feet to a point in said road; thence crossing said road, S. 16-15 W. 755.2 feet to line of property now or formerly of Sue H. Earle; thence with Earle property, N. 37-15 W. 1148 feet to a point; thence N. 1-30 E. 254.5 feet to a stake; thence still with Earle property, N. 37-00 W. 1118 feet to a stake in line of property now or formerly of Crouch; thence N. 1-30 E. 1069.6 feet to stake in line of property now or formerly of Lawrence Reid; thence along Reid property, S. 73-30 W. 1782 feet to a point; thence continuing with Reid property, S. 36-30 E. 1061 feet to point of beginning.

Being the identical property conveyed to the mortgagor by deed of Dock J. Hudson recorded in Deed Book 355, page 335, R. M. C. Office for Greenville County, S. C.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
