TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **O. Y. Brownlee**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **First National Bank**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Three Thousand and No/100- - -**

DOLLARS (\$ 3000.00),

with interest thereon from date at the rate of **Six** per centum per annum, said principal and interest to be repaid: **Sixty days from date**. Said interest is from date at **six per cent** and is payable quarterly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of **Three (\$3.00) Dollars** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

^{those} ~~Albion~~ certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the **Northern side of Sycamore Drive in the City of Greenville**, being shown as lot No. 59 and lot No. 60 on Plat of East Lynne made by Dalton & Neves in June 1931, revised in February 1933, and recorded in Plat Book "H" at Page 195, and described as follows:

"BEGINNING at a stake on the Northern side of Sycamore Drive, 110.4 feet West from Boland Street, at corner of lot No. 58, and running thence with the line of said lot, N. 9-14 W. 156.2 feet to a stake in line of lot No. 102; thence with the line of said lot, S. 81-02 W. 50 feet to a stake in line of lot No. 61; thence with the line of said lot, S. 9-14 E. 147.3 feet to a stake on Sycamore Drive; thence with the Northern side of Sycamore Drive, S. 87-44 E. 51 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by deed recorded in Volume 375 at Page 189.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
